

Summary of Key Points
Analysis of Exit Destinations by County and Program Type
For September 2017

The HMIS admin team completed analysis of client exit destinations from HMIS program discharge records for the month of September 2017 (n = 1,495). The analysis presents findings by county, over program type, and by program.

The summary tables show the total exits by destination category, along with permanent housing exit rates. Analysis also includes the total number of exits with unknown exit destination type along with the corresponding exit rates.

Key findings of the monthly reporting include:

- In aggregate, the PH exit rate for September was 34% with 507 of 1,495 exits
- It should be noted that Street Outreach and Emergency Shelter project types should not be evaluated solely on exits to PH. Placements into institutional settings, shelters, or residential projects are usually positive outcomes.
- September PH rates by county were Hawaii (57%), Kauai (37%), Oahu (31%), Maui (25%).
- Homeless Prevention and Rapid Re-Housing Programs typically had the highest PH rates due to the inherent nature of these programs.
- The number of clients with unknown exit data increased from 414 clients in August to 461 clients in September, however, the missing exit data rate was steady at 31%.
- Oahu and Maui had the most exits to unknown locations in September, with 38% and 27% of all discharges exiting to these destinations. Usually the exits within these categories were from ES or Outreach projects however, Maui also had a high rate within this category exiting from the TH project type.
- Oahu Homeless Outreach programs had the highest rate of missing exits in September (81%), which can generally be attributed to auto-exiting in the system. This should continue to be monitored, however, especially with HPO contracts shifting towards a housing first approach. One report that contains the last encounter date for each client is the HI Custom Export data. Once exporting to excel the last encounter date is the last field in this report. This report can be used as a tool to assist providers in monitoring which clients are approaching auto-exit.
- The graph on page 2 of this report shows that 43% (219) of the exits to PH came from either Homeless Prevention or RRH projects, shelter projects accounted for 45% (230) of the exits, while outreach projects accounted for 11% (56) of the total exits during the month.

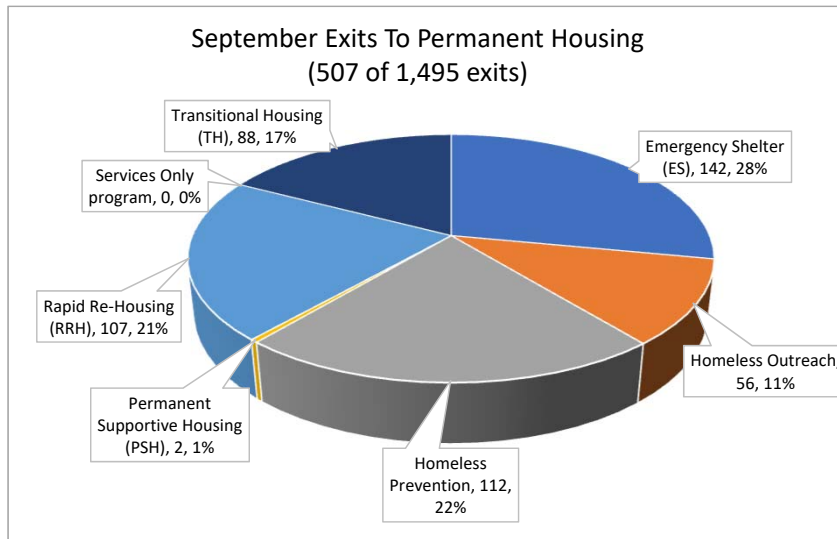
