Re: March 2021 HMIS Monitoring Reports (Neighbor Islands – Bridging the Gap)

Attached for your review and dissemination to Continuum agencies is the March 2021 HMIS monitoring report. Below are brief highlights from the attached reports.

1. End of month, March 2021 Census summary by Continuum and Statewide (pp. 2-5)
 - The Neighbor Island census for emergency shelter (ES) and transitional housing (TH) programs decreased in March 2021 (600), compared to February (607), with an increase in ES, but a decrease in TH.
 - The total “vacant beds” compared to the HIC bed capacity was 403 (ES and TH) and 66 (permanent supportive housing – PSH). This is an increase compared to last month. HIC openings can also vary depending on differences in household size.
 - 35 programs on the Neighbor Islands had utilization rates of less than 85% or greater than 110%. These programs are marked in red.
 - Active outreach clients totaled 546, an increase compared to February (500 clients).
2. Consent report for March 2021 (pp. 6-11)
 - VI-SPDAT Assessments: Consent to share data rate for Neighbor Islands was 100%, an increase compared to February (97%).
 - By Name List consent to share data rate as of the 03/31/21 BNL cut was 99% for the CoC, the same rate as in February.
 - For adult program intakes entered in March 2021 (n=234), the Neighbor Islands consent to share data rate was 99%, one percentage point higher than in February (98%).
 - For March intakes, one program had a consent rate below 80%.
3. Length of stay (LOS) by agency and program for clients exiting during March 2021 (pp. 12-14)
 - The average LOS over all programs was 135 days (representing 241 exits), a decrease compared to February (138 days); March’s LOS was lower than the 12-month average for Neighbors Islands LOS (141 days) from April 2020 – March 2021.
 - This month, excluding PSH, the average LOS was 130 days.
 - Homeless Prevention and Emergency Shelter programs’ LOS were the shortest (103 and 108 days). Permanent Supporting Housing and Transitional Housing programs’ LOS were the longest (1260 and 317 days).
 - By County, Maui (148) averaged the longest LOS, followed by Hawaii (135 days), and Kauai (100 days).
 - Emergency shelter average LOS ranged from 38 days on Kauai to 129 days on Maui.
 - Transitional housing average LOS was 317 days on Kauai; no TH exits were recorded for Hawaii or Maui.
4. Timeliness (entries and exits) during March 2021 (pp. 15-18)
 - Intake timeliness decreased to 1.47 average days, from 2.07 average days in February.
 - Six programs (highlighted in RED) averaged more than 3 days to enter intakes.
 - Exit timeliness increased to 2.15 average days, compared to 1.97 average days in February.
 - Seven programs (highlighted in RED) averaged more than 3 days to enter exits.

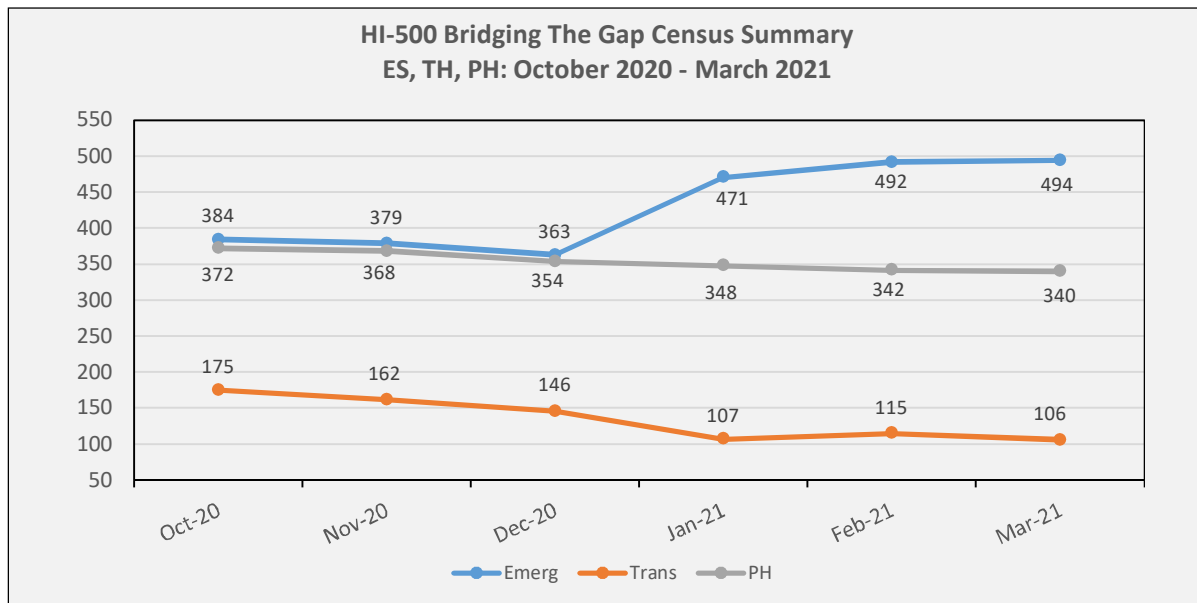

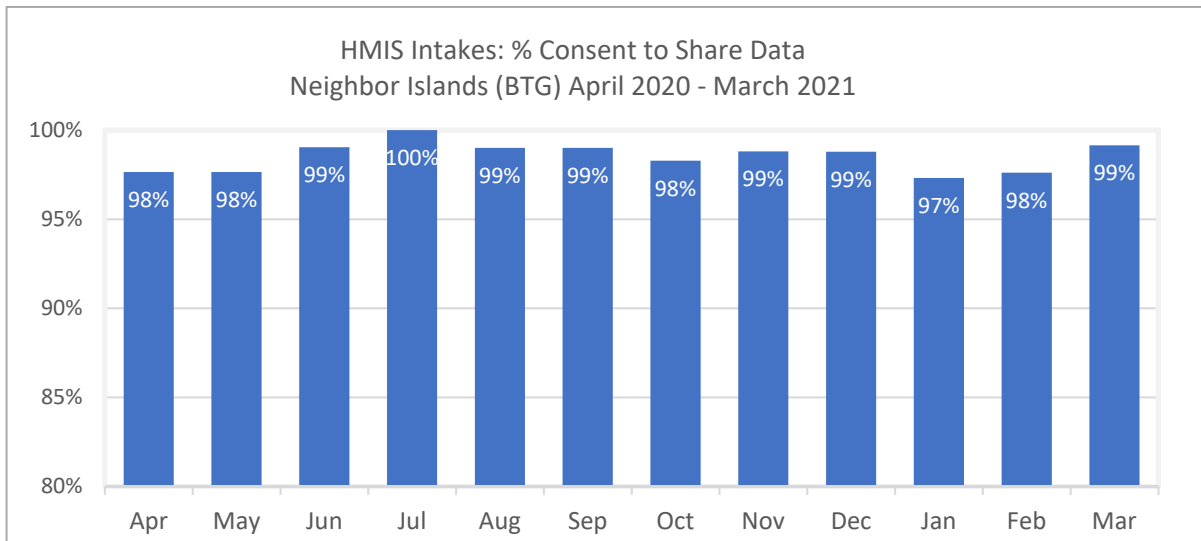
