Re: April 2020 HMIS Monitoring Reports (Neighbor Islands – Bridging the Gap)

Attached for your review and dissemination to Continuum agencies is the April 2020 HMIS monitoring report. Below are brief highlights from the attached reports.

1. End of month, April 2020 Census summary by Continuum and Statewide (pp. 2-4)
 - The Neighbor Island census for emergency shelter (ES) and transitional housing (TH) programs decreased in April 2020 (560), compared to February (578), with a decrease in ES, but an increase in TH.
 - Over the past six months, the census in ES and TH programs have been on a decreasing trend, but there the census for PH programs has continued to increase. The monthly combined census (ES, TH, PSH) has fluctuated over the past year from a low of 823 in May 2019 to a high of 982 in February 2019.
 - The total “vacant beds” compared to the HIC bed capacity was 264 (ES and TH) and 91 (permanent supportive housing – PSH). This is an increase for ES and TH, but a decrease for PSH compared to last month. HIC openings can also vary depending on differences in household size.
 - 25 programs on the Neighbor Islands had utilization rates of less than 85% or greater than 110%. These programs are marked in red.
 - Active outreach clients totaled 379, a decrease compared to March 2020 (391 clients).
2. Consent report for April 2020 (pp. 5-10)
 - VI-SPDAT Assessments: Consent to share data rate for Neighbor Islands was 98%, one percentage point lower than the past three months (99%).
 - By Name List: Consent to share data rates as of the 4/30/20, BNL cut was 99% for the CoC. April rates included: 100% for Kauai families and singles and for Maui families; 99% for Hawaii and Maui singles; and 94% for Hawaii families.
 - For adult program intakes entered in April 2020 (n=212), the Neighbor Islands consent to share data rate was 98%, one percentage point lower than in March 2020.
 - One program had a consent rate below 80%.
3. Length of stay (LOS) by agency and program for clients exiting during April 2020 (pp. 11-12)
 - The average LOS over all programs was 129 days (representing 211 exits), an increase compared to March 2020 (116 days).
 - The average LOS for Neighbors Islands in April (129 days) was lower than the statewide average LOS for all months from April through August 2019 (181 days), and slightly higher than the average LOS for Neighbor Island programs from September 2019 – April 2020 (126 days).
 - Excluding PSH, the average LOS was 112 days.
 - ES and outreach programs’ LOS were the shortest (87 and 109 days). PSH and services only programs’ lengths of stay were the longest (986 and 224 days).
 - By County Hawaii (172) averaged the longest LOS, followed by Maui (108 days) and Kauai (93 days).
 - Emergency shelter average LOS ranged from 48 days on Maui to 107 days on Kauai.
 - Transitional housing average LOS ranged from 188 days on Maui to 254 days on Hawaii.
4. Timeliness (entries and exits) during April 2020 (pp. 13-15)
 - Intake timeliness was 2.07 average days, an increase compared to 1.46 average days in March.
 - 11 programs (highlighted in RED) averaged more than 3 days to enter intakes.
 - Exit timeliness decreased to 1.35 average days, an increase compared to 1.08 average days in March.
 - 7 programs (highlighted in RED) averaged more than 3 days to enter exits.

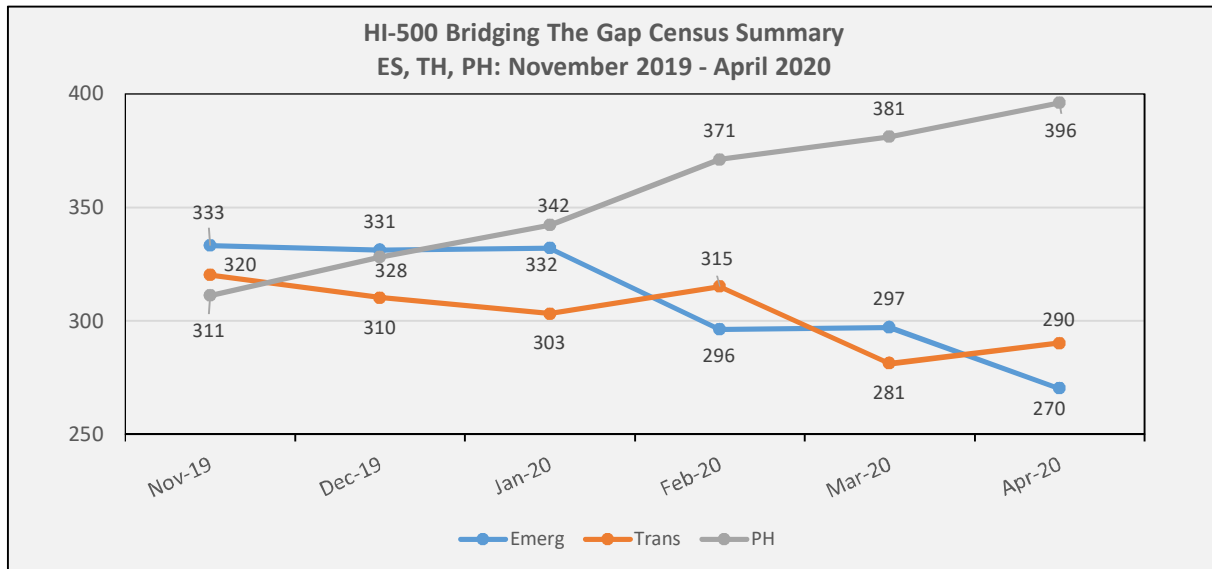

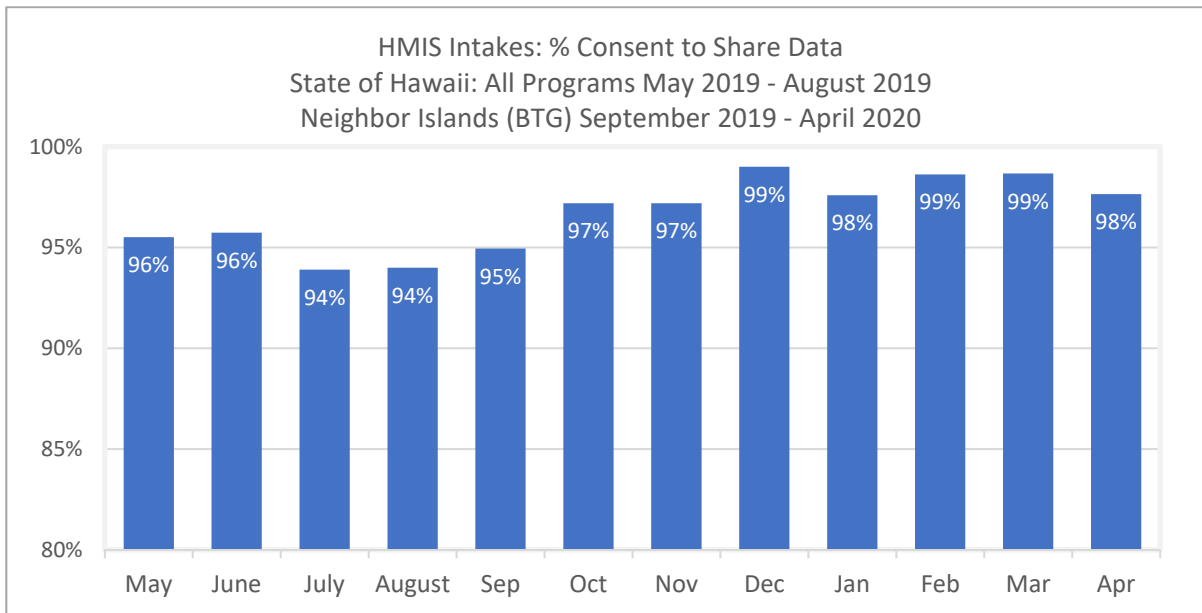
