Re: October 2020 HMIS Monitoring Reports (Neighbor Islands – Bridging the Gap)

Attached for your review and dissemination to Continuum agencies is the October 2020 HMIS monitoring report. Below are brief highlights from the attached reports.

1. End of month, October 2020 Census summary by Continuum and Statewide (pp. 2-4)
 - The Neighbor Island census for emergency shelter (ES) and transitional housing (TH) programs increased in October 2020 (559), compared to September (544), with an increase in ES, but a decrease in TH.
 - The total “vacant beds” compared to the HIC bed capacity was 413 (ES and TH) and 55 (permanent supportive housing – PSH). This is the same for ES and TH, and an increase for PH programs compared to last month. HIC openings can also vary depending on differences in household size.
 - 26 programs on the Neighbor Islands had utilization rates of less than 85% or greater than 110%. These programs are marked in red.
 - Active outreach clients totaled 487, an increase compared to September 2020 (407 clients).
2. Consent report for October 2020 (pp. 5-10)
 - VI-SPDAT Assessments: Consent to share data rate for Neighbor Islands was 99%, one percentage point less than in September (100%).
 - By Name List consent to share data rate as of the 10/31/20: BNL cut was 99% for the CoC, the same rate as in September.
 - For adult program intakes entered in October 2020 (n=291), the Neighbor Islands consent to share data rate was 98%, one percentage point less than in September (99%).
 - For October intakes, three programs had a consent rate of 80% or below.
3. Length of stay (LOS) by agency and program for clients exiting during October 2020 (pp. 11-13)
 - The average LOS over all programs was 152 days (representing 393 exits), a decrease compared to September 2020 (157 days); October’s LOS was higher than the ten-month average for Neighbors Islands LOS (138 days) from January – October 2020.
 - This month, excluding PSH, the average LOS was 143 days.
 - Emergency Shelter and Street Outreach programs’ LOS were the shortest (99 and 109 days). Permanent Supportive Housing and Services Only programs’ LOS were the longest (598 and 359 days).
 - By County, Hawaii (199) averaged the longest LOS, followed by Maui (138 days) and Kauai (85 days).
 - Emergency shelter average LOS ranged from 21 days on Kauai to 121 days on Hawaii.
 - Transitional housing average LOS ranged from 20 days on Kauai to 222 days on Maui.
4. Timeliness (entries and exits) during October 2020 (pp. 14-17)
 - Intake timeliness was 1.77 average days, an increase compared to 1.17 average days in September.
 - 11 programs (highlighted in RED) averaged more than 3 days to enter intakes.
 - Exit timeliness decreased to 0.99 average days, compared to 1.03 average days in September.
 - 8 programs (highlighted in RED) averaged more than 3 days to enter exits.

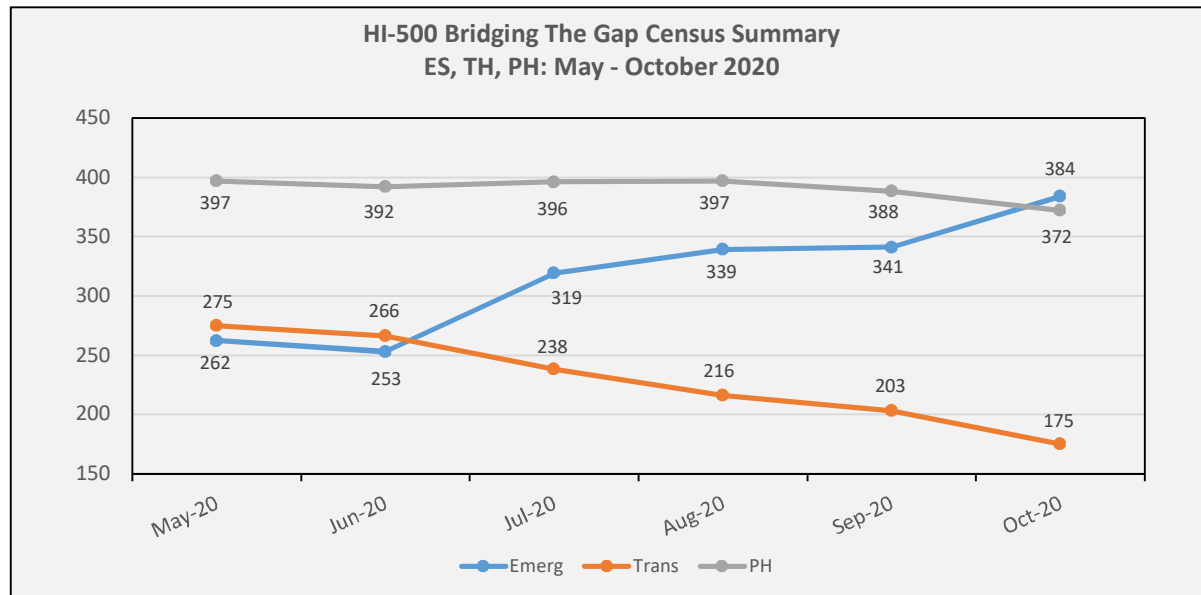

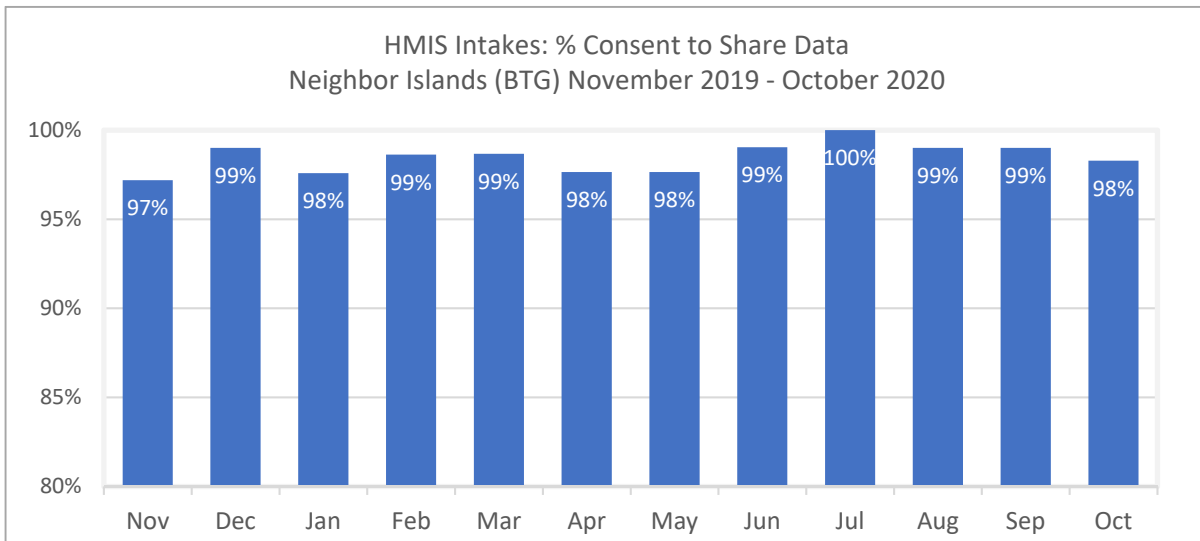
