Re: December 2020 HMIS Monitoring Reports (Neighbor Islands – Bridging the Gap)

Attached for your review and dissemination to Continuum agencies is the December 2020 HMIS monitoring report. Below are brief highlights from the attached reports.

1. End of month, December 2020 Census summary by Continuum and Statewide (pp. 2-5)
 - The Neighbor Island census for emergency shelter (ES) and transitional housing (TH) programs decreased in December 2020 (509), compared to November (541), with a decrease in both ES and TH.
 - The total “vacant beds” compared to the HIC bed capacity was 502 (ES and TH) and 58 (permanent supportive housing – PSH). This is an increase for ES and TH, and PH programs compared to last month. HIC openings can also vary depending on differences in household size.
 - 34 programs on the Neighbor Islands had utilization rates of less than 85% or greater than 110%. These programs are marked in red.
 - Active outreach clients totaled 496, an increase compared to November 2020 (468 clients).
2. Consent report for December 2020 (pp. 6-11)
 - VI-SPDAT Assessments: Consent to share data rate for Neighbor Islands was 100%, an increase compared to November (98%).
 - By Name List consent to share data rate as of the 12/31/20 BNL cut was 99% for the CoC, the same rate as in November.
 - For adult program intakes entered in December 2020 (n=247), the Neighbor Islands consent to share data rate was 99%, the same rate as in November.
 - For December intakes, one program had a consent rate of 80% or below.
3. Length of stay (LOS) by agency and program for clients exiting during December 2020 (pp. 12-14)
 - The average LOS over all programs was 139 days (representing 275 exits), an increase compared to November 2020 (124 days); December’s LOS was higher than the 12-month average for Neighbors Islands LOS (137 days) from January – December 2020.
 - This month, excluding PSH, the average LOS was 124 days.
 - Homeless Prevention and Emergency Shelter’s LOS were the shortest (91 and 67 days). Permanent Supporting Housing and Transitional Housing programs’ LOS were the longest (489 and 581 days).
 - By County, Hawaii (200) averaged the longest LOS, followed by Kauai (123 days) and Maui (82 days).
 - Emergency shelter average LOS ranged from 63 days on Kauai to 71 days on Hawaii.
 - Transitional housing average LOS ranged from 577 days on Hawaii to 623 days on Kauai.
4. Timeliness (entries and exits) during December 2020 (pp. 15-18)
 - Intake timeliness decreased to 1.46 average days, from 1.52 average days in November.
 - Six programs (highlighted in RED) averaged more than 3 days to enter intakes.
 - Exit timeliness decreased to 0.93 average days, compared to 2.14 average days in November.
 - Nine programs (highlighted in RED) averaged more than 3 days to enter exits.

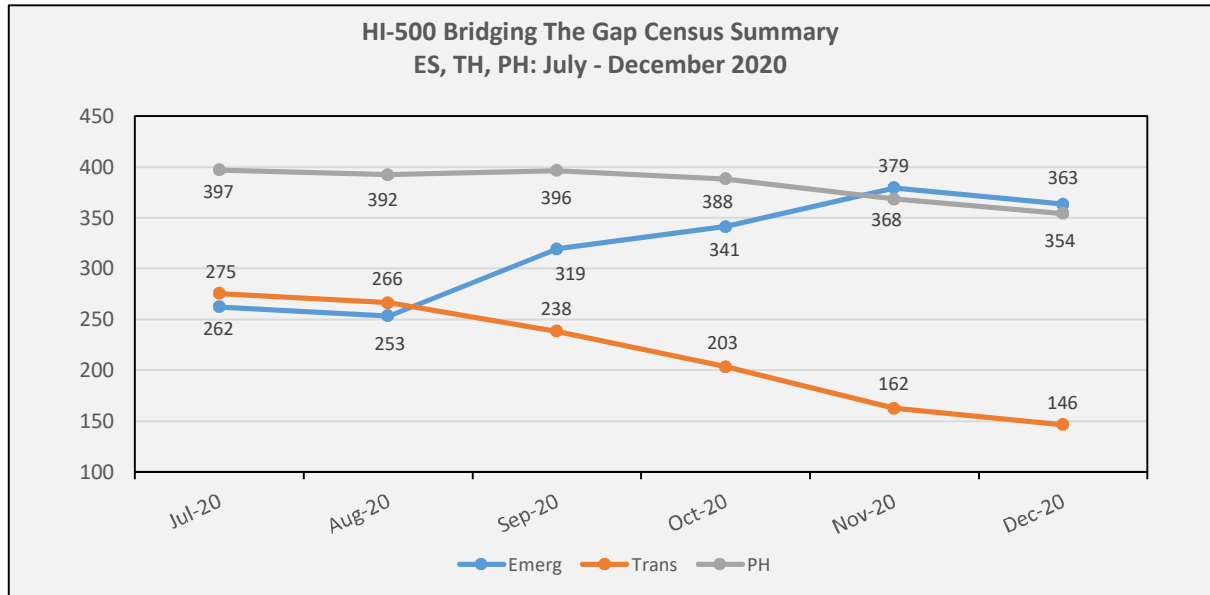

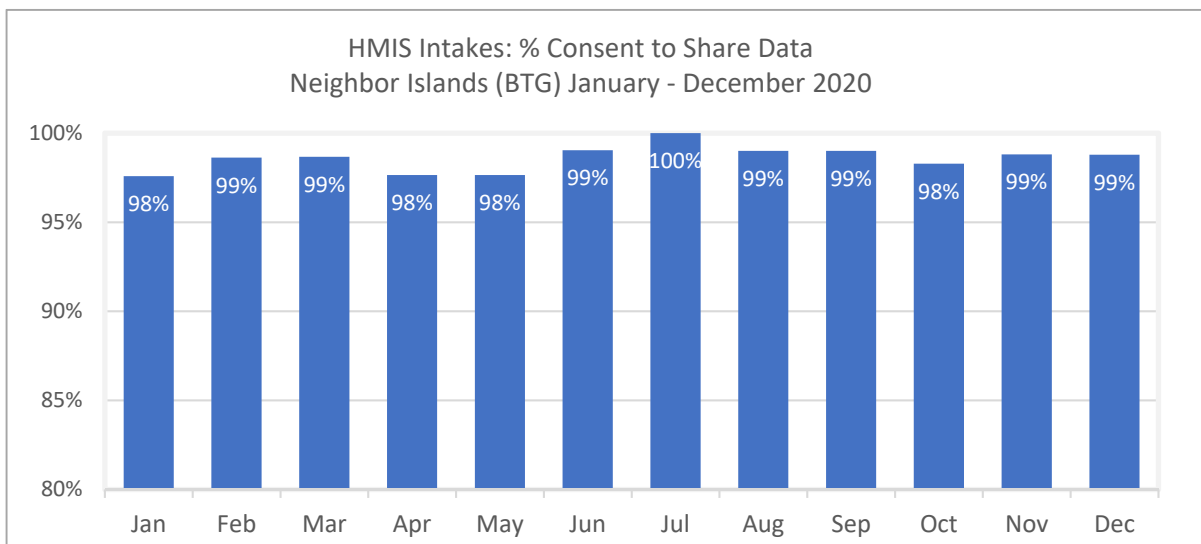
